Statewide Ballot Questions

The Chicago Federation of Labor *supports* the following ballot questions:

Proposed Constitutional Questions:

1. **The Illinois Crime Victims' Bill of Rights Amendment:** A legislatively-referred constitutional amendment that would strengthen the Crime Victims' Bill of Rights. Specifically, the amendment would guarantee the following:
 - a. A victim's right to be free from harassment, intimidation and abuse throughout the criminal trial process.
 - b. A victim's right to notice and to a hearing before a court ruling on access to any of the victim's records, information or communication.
 - c. A victim's right to be heard at any post-arraignment court proceeding in which a victim's right is at issue and at any court proceeding involving a post-arraignment release decision, plea or sentencing.
 - d. A consideration of the safety of the victim and their family in determining bail and conditions of release after arrest and conviction of the defendant.
 - e. That the accused does not have standing to assert the rights of a victim.
2. **Voting Rights:** Proposes to amend the Suffrage and Elections Article of the Constitution. Provides that no person shall be denied the right to register to vote or to cast a ballot in an election based on race, color, ethnicity, status as a member of a language minority, sex, sexual orientation, national origin, religion or income.

Statewide Advisory Questions:

1. **Minimum Wage Raise:** This is a statewide advisory question concerning whether the minimum wage in Illinois for adults over the age of 18 should be raised to \$10 per hour by January 1, 2015.
2. **Millionaire's Tax:** This is a statewide advisory question of public policy to be submitted to the voters at the general election asking whether the Illinois Constitution should be amended to require that each school district receive additional revenue, based on their number of students, from an additional 3 percent tax on income greater than \$1,000,000.
3. **Birth Control:** This is a statewide advisory question asking whether any health insurance plan in Illinois that provides prescription drug coverage should be required to include prescription birth control as part of that coverage.
